

## Facts-at-a-Glance

Driver results for 2016 are as follows:

- All Level I, II and III inspections: 96.0 percent of drivers had no out-of-service (OOS) violations, and 4.0 percent were placed out of service.
- Level I inspections: 96.6 percent of drivers had no OOS violations, and 3.4 percent were placed out of service.
- Inspections with hazardous materials (HM): 98.3 percent of drivers carrying HM had no OOS violations, and 1.7 percent were placed out of service.
- Passenger-carrying vehicles: 97.1 percent of drivers had no OOS violations, and 2.9 percent were placed out of service.

Vehicle results for 2016 are as follows:

- All inspections: 82.2 percent of vehicles had no OOS violations, and 17.8 percent were placed out of service.
- Level I inspections: 78.5 percent of vehicles had no OOS violations, and 21.5 percent were placed out of service.
- Inspections with hazardous materials: 87.0 percent of vehicles carrying HM had no OOS violations, and 13.0 percent were placed Out of service.
- Passenger-carrying vehicles: 93.9 percent of vehicles had no OOS violations, and 6.1 percent were placed out of service.

The specific OOS violation percentage distributions (numbers indicate a percentage of the total OOS violations by category) from 2014-16 are shown below:
